The Faribault County Fair Board is planning a grand celebration for this anniversary fair and we would like to invite you to be a part of it. Exhibitors and vendors are an important part of the fair because of the education and the service they provide to fair goers.

Space available for you to sell your food product is at a premium this year. We are expecting larger than usual crowds, so apply soon for your space. Breakdown will be after 4:00 PM on Sunday, July 20th. *NOTE a change from prior years will be NO VEHICLES allowed in the vendor areas after 10:30 AM.*

Restocking must be done prior to this time. **Each vendor will receive one free parking pass for the week. You must supply your own tables and chairs.** Electricity and water is available if needed. **You must supply extension cords and hoses.**
