Welcome to the 161st Faribault County Fair which will run **Wednesday, July 27th, through Saturday, July 30th, 2022**. The fair building hours during the fair will be: Wednesday – Friday, 11:00am to 10:00pm and Saturday 11:00am to 8:00pm.

The Faribault County Fair Board is planning for another exciting fair! We would like to invite you to be a part of it. Exhibitors and vendors are an important part of the fair because of the education and the services that they provide to the fair goers.

Commercial Exhibit space (Indoor and Outdoor) is now available for you to reserve to display and/or sell your products at the Fair. Time schedule for setup is Tuesday, July 26th, through 11:00am, Wednesday, July 27th. Exhibit removal will be after 8:00pm on Saturday, OR between 10:00am and 2:00pm, Sunday, July 31st. Indoor building spaces will be 10'x10' and separated with traditional curtained dividers. **Each booth/vendor will receive one free parking pass for the week. You must supply your own tables and extension cords.** Electricity is available to all spaces, which is reflected in the price.

If you would like to be a part of this celebration, please complete the enclosed forms and mail them to the Faribault County Fair, along with your certificate of insurance coverage from your insurance agent, the ST19 form with your MN Tax ID number, and your check made payable to Faribault County Fair. **Reservations are due by June 1, 2022.**
